**Definitions of Youth-on-Youth Sexual Abuse and Sexual Harassment**

***Nonconsensual Sexual Acts*** -- Contact of any person without his or her consent, or of a person who is unable to consent or refuse AND: Contact between the mouth and the penis, vagina, or anus; contact between the penis and the vagina or the penis and the anus including penetration, however slight; and/or penetration of the anal or genital opening of another person by a hand, finger, or other object.

***Abusive Sexual Contacts*** -- Contact of any person without his or her consent or of a person who is unable to consent or refuse; AND intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh, or buttocks of any person. Excludes incidents in which the intent of the sexual contact is to harm or debilitate rather than sexually exploit.

***Youth-on-Youth Sexual Harassment*** -- Includes repeated resident-on-resident verbal statements or comments of a sexual nature; repeated profane or obscene language or gestures; repeated requests for sexual favors; and/or demeaning references to gender or derogatory comments about body or clothing.

Sexual relationships of a romantic nature between staff and youth are included in this definition. Consensual or nonconsensual sexual acts include: Intentional touching of the genitalia, anus, groin, breast, inner thigh, or buttocks with the intent to abuse, arouse, or gratify sexual desire; completed, attempted, threatened, or requested sexual acts; and/or occurrences of indecent exposure, invasion of privacy, or staff voyeurism for sexual gratification.

<p><b>Staff Sexual Harassment</b> -- Includes repeated verbal statements or comments of a sexual nature to a juvenile or youthful offender by an employee, volunteer, contractor, office visitor, or other agency representative (exclude youth family, friends, or other visitors); repeated profane or obscene language or gestures; and/or demeaning references to gender or derogatory comments about body or clothing.</p>
